Among the greatest strengths of firefighters are adaptability, ingenuity, and possession of a can-do attitude. We have all been tested in these strengths over this last year, and the rigors of our careers demand we stay strong, positive, and continue to improve ourselves in our craft at every opportunity. The Board is extremely optimistic and is looking forward to catching up on old friendships, developing new ones, and offering a conference to represent the hard work you do every day when the bell goes off. As always, your Board and I remain open to your input and welcome any feedback you may have to continue our legacy this year with the 90th Annual Wildland Fire Safety & Training Conference.
